## **Payment Terms:**

**Registration:** 10 % to be paid for registration confirmation along with Required Documents. **Visa Confirmation:** 50 % after Visa Confirmation **Final Preparation:** 40% 1 Month before Travel

## **Registration and Visa Process:**

- 2. Visa Consultant will Review Documents and Contact You.
- **3.** After confirmation from Visa Consultant you have to Transfer / Deposit Registration Fee in following Account.

- **4.** After Payment Confirmation, You need to send Payment Transfer Slip to <u>info@icmtravellers.com</u> or deposit ICM Office or send through whatsapp.
- 5. ICM Team will prepare visa file with additional required documents from ICM side and initiate visa process.
- 6. Based on Embassy Requirements you might need to go for Interview / Biometrics / Passport Submission.

## Visa Rejection

Rejected by Embassy: Full Registration Fee paid to ICM will be refunded.
